## The Neighbourhood Planning (General) Regulations 2012 (Regulation 14).




Hankelow Parish Council, as the qualifying body, has prepared a Neighbourhood Plan for the period to 2030 (the Plan) for Hankelow Parish with the help of the local community. The Plan sets out a vision for the future of the Parish and planning policies, which will be used to determine planning proposals locally.

Hankelow Parish Council is now inviting comments on the proposals in this Pre-Submission version of the Plan before it is submitted to Cheshire East Council for formal consideration and wider consultation. This is part of the Regulation 14 procedure to gain approval of the Hankelow Neighbourhood Plan.

The consultation opens for comment on **October 7th 2019**. The deadline for comments to be received by Hankelow Parish Council is **5pm** on **November 18th 2019**
